In answer to your inquiry, the City of Massillon requires all Plumbing Contractors to be registered with the City of Massillon. To become registered as a Plumbing Contractor, you will need:

1. To fill out an application. There is a \$75.00 non-refundable fee.
2. To submit a copy of your current State License.
3. To submit a copy of your Worker's Compensation certificate, should you have employees.
4. To submit a copy of your Driver's License
5. Obtain a \$5,000.00 surety bond – form enclosed.
6. To submit a yearly registration fee of \$150.00 The registration is good through February 28th of each year. The registration belongs to the person who holds the State License and should he/she leave the company, the registration goes with him/her.
7. Permits are to be obtained before starting the job and it is your responsibility to call for all needed inspections.
